## Justification of the debit note

REPUBBLICA ITALIANA - PROVINCIA DI ROMA was awarded a grant for the Call for Proposals VP/2011/006 for a total estimated cost of EUR 1,108,615.79. The grant decided upon was EUR 1,025,919,71 equivalent to 92.54 % of the estimated cost. On the basis of the documents submitted, the real cost for this action amounts to EUR 664,318.77 and the total accepted costs amount to EUR 664,309.77. The pro-rata applicable for the calculation of the grant is 92.54 % As a result, the decided amount of the grant is EUR 614,756.25. According to the article II.17.6 of the grant agreement, as REPUBBLICA 1TALIANA PROVINCIA DI ROMA has already received an advance payment of EUR 718,143.79, the difference between the aggregated payments and the value accepted by the Commission is the difference between this amount and the value accepted by the Commission is 103,387.54 (718,143.79 - 614,756.25). In accordance with art. 80 of the Financial Regulations applicable to the general budget of the European Communities - "the accounting officer shall recover amounts by offsetting them against equivalent claims that the Communities have on any debtor who himself has a claim on the Communities that is certain, of a fixed amount and due".
